## 1063/16 STRATEGIC RAIL FREIGHT INTERCHANGE

At a recent meeting of the SRFI Community Liaison Group an update on the forward plans was given and a confirmed start date of 9 January 2017. Although the start date is slightly later than originally anticipated, the end date of December 2019 remains the same due to the need to work with Network Rail to ensure the rail connections. One of the major concerns raised at the meeting was traffic, in particular, the issue of HGV movements during the development which will only exacerbate the current situation. With this in mind, the Group has asked if LCC could be invited to the next meeting, now set for January 25th, same time/venue. Prior to the meeting, the Group would request details of the total signage information (pre and post development) so it can analysed allowing members to give specific feedback about local concerns.

At the meeting matters for discussion would centre around:

- LCC's signage and enforcement plans (particularly but not restricted to HGV's)
- LCC's reassurance that it has considered the coordination of ALL the different projects which will/may overlap with Roxhill's (e.g. But not limited to, the Smart Motorway work)
- LCC's understanding, appreciation and planning of the displacement effect of this development, i.e. What non development traffic and particularly HGV's do to avoid junction 24 (as we witnessed during the last modification of Junction 24)

NWLDC CEO and the Police are keen that the parishes work together to obtain a proactive plan to help eliminate and improve the current and future issues. Therefore, following on from a previous resolution to set up a Working Party of Castle Donington Parish Council to this effect, it would seem ultimately that a "Cluster Group" of all parishes should be set up formally to review and address issues. This should be organised and held prior to the SRFI in January 2017.
