Every smaller authority in England with an annual turnover of £6.5 million or less must complete an annual return at the end of each financial year in accordance with proper practices summarising its activities. Send the annual return, together with the bank reconciliation as at 31 March 2017, an explanation of any significant year on year variances in the accounting statements, **your notification of the commencement date of the period for the exercise of public rights** and any additional information requested, to your external auditor by the due date.

Your external auditor will ask for any additional documents needed for their work. Unless requested, do not send any original financial records to the external auditor.

Once the external auditor has completed their work, certified annual returns will be returned to the smaller authority for publication and public display of Sections 1, 2 and 3. You must publish and display the annual return, including the external auditor's report, by 30 September 2017.

Matters reported

RFO certification

The Accounts and Audit Regulations 2015 and proper practices stipulate that the Responsible Financial Officer must certify the Accounting Statements and the Authority must approve both the Annual Governance Statement and Accounting Statements in the Annual Return before the commencement of the period for exercise of public rights.

The Responsible Financial officer certified the Accounting statements on 29 June 2017 and the Authority approved the Annual Return on the same date. The date of commencement of the period for the exercise of public rights was 09 June 2017, which is before the accounting Statements were certified and approved, so the Authority has not met these requirements. The Authority does not have in place proper arrangements for the preparation and approval of the statement of accounts in accordance with proper practices and relevant legislation. In our view, the response to Assertion 1 on the Annual Governance Statement should be 'No'.

In future, the Authority must ensure that it properly approves and publishes the Annual Return in advance of the commencement of the exercise of public rights. The Authority should also consider the impact of this on Assertion 4 in the 2017/18 Annual Governance Statement.

External Audit notes

Grant Thornton have now signed off the Audit for 2016-17.

Last week, they came back to the Clerk with a lot of questions which required answering in a very short space of time, mainly around the purchase of the Hub. The Audit, must be concluded by the 30 September. They had had the Parish Council's audit papers since the beginning of July too, but had only just come to us for additional information.

When they returned the Annual Return this week, they included a letter stating that the forms had not been supplied by the RFO and that the Parish Council had now complied with Assertion 1, Section 1 Annual Governance Statement (prepared the accounts in accordance with the Accounts and Audit Regulations). The letter was actually incorrect, and they had not actually explained clearly what the issue was.

Having spoken to the Auditor, they confirmed that the forms had been signed correctly, but the issue was that the Public Rights to view the accounts advertising notice had not been complied with in accordance with new changes to this regulation. The accounts had been advertised from 9 June to last week, but not the signed version which is the issue. It should have been the signed version, but this is a difference process to in previous years. The other issue, is that because they have only just looked at the Parish Council's Audit, they could not find the advert on the website. This is because they were advertised on the old website, but not on the new. The new one went live end of July.

These are both minor points, but they have to raise the issue, and now that they have explained the new processes in plain English, the notices will be displayed accordingly for next year.

They have reissued the side letter stating this, which is included in with this report and the Annual Report.
