From Wednesday 13 March, around 6,500 households in Coalville, Greenhill and some rural areas will receive fortnightly collections of plastics such as:

- Plastic bags
- Crisp packets
- Chocolate and sweet wrappers
- Bubble wrap and cling film Baby/pet food pouches

Leicestershire & Rutland Association of Local Councils (LRALC) is reminding every town and parish council that they should have a -pc.gov.uk domain name.

Some councils might not previously have put these in place due to cost or perceived difficulty in setting up. The Cabinet Office has taken away both of those issues by launching the Parish Council Domains Helper Service, formerly known as the Small Organisation Helper Service.

# **Funding**

#### **Zero Carbon Grants**

As part of our Zero Carbon commitment, we are offering Zero Carbon Grants of £50 to £500 each for environmentally -focused community projects across the district. These are simple projects that make a big impact and are open to groups and organisations, including parish councils. Match funding of £50 to £500 is required; this needs to be cash as opposed to in-kind funding.

#### **Green Living Leicestershire Home Upgrade Grant**

This scheme aims to improve the warmth and comfort of homes that do not have mains-gas heating, whilst also reducing energy bills, carbon emissions and levels of fuel poverty. Eligible households could receive free energy



efficiency improvements or clean heating (such as air source heat pumps) for their homes, following a home assessment.

#### Community **Ownership Fund** This Government

fund is to help communities across the UK to take ownership of assets/ properties at risk of closure. Capital grants of up to £250,000 and revenue grants of up to £50,000 are available. Parish and town councils can also apply. Expressions of interest can be submitted at any time. If successful, applicants will be invited to submit a full application. The programme will run until March 2025.
